So we have a system down, and we use three people. And that's the way, you know, that that's what makes it work smoothly, and that's why we're so good in the past. So they need to bear with us. It's gonna be a cooler weekend this weekend that will hold back some boaters. And then hopefully next week, when we get our staff back, those docks are going to be in. And there's some other things we'll address. What I'd like to do right now is get Glenn Roberts from the DEC For Forestry Department. Yes, some information, I think, on some trees that are being planted on the State Loop Project that he's concerned about, and I think he wanted to address those. I know I brought on board in the past, but now, you've got some expertise to actually blended some information to your plan, If you're there, you'd like to take over.

One of the main concerns that came out in the right of way is that one species of tree, Canadian Red, or to Virginia, and the Canadian red, big disease and. That is Disease prone. It gets a disease called black rot, which probably know, it probably wouldn't. You wouldn't see it for 8 to 10 years, and then all of a sudden, the trees become very slightly with the black knot on the twigs. It wouldn't necessarily totally trees right out, but they're gonna look unsightly. And so, there are two main concern, I would recommend that you just take a job, remove the tree from the list, and provide some other suggestions, and better main ..., trees, character variety. Ok, good, In my mind, that's not a good thing for, because, if something happens to the tree, example, one species is an elm, it is probably a good selection. But, If something happened to them, it's supposed to be Dutch Elm disease resistant, but if something happens to those trees, then you lose 14 trees at the same time. So, my suggestion might be that. You think about trying to get more variety out there, if you can. That's, that's one of the comments, There's another species, it's called the ... Choke Cherry. I don't really have any Experience with a tree in the north country, it might be a good choice, is has a really good recommendation. But, it really hasn't been planted much. So, it, I think you can take information. Came in 16 trees or you go to 82 trees, goes into planning, and if you could get it more diversified, I think that it would give you trees that would and you get more or less an you'd have a better variety. The trees may. When they die, they might not die within a short period. That is pretty much the comments. Any questions?

Did Terry talk to you about the emerald ash bore.
