Anybody gives them a call, and they can get their snow, their sidewalk cleared, he'd be more than happy to go over there and do that. So, that's about the best answer I can give and we're trying to keep up on it. Kevin and I looked at a few last week. But again, it just keeps snowing, so it's hard to keep up with them.

So we're looking forward to implementing that strategy, going forward every year, for the manholes that need to be inspected. And so you can see that, in this time, around, no, there, most of the man holes are in good, or fair condition, and there was 13 that require some kind of repair. Most of them, it was just cleaning. That needed to happen. And then there were four that were inspected, and I, couple of those work, because they are, they

needed to be added to the GIS, or they were just listed in the field, and probably user error. They maybe had tried to do the inspection, but it didn't go through it. So we'll just add those on to next year, but all at all, this inspection this year went very well once we got it going. And the new system works really nicely. So we'll keep going with that. Then the only other thing that I just wanted to touch on here on the agenda to Norma is I did submit the Water and Sewer Annual edu Update report. So, if you guys want to read through that and let me know if there's any feedback. Because of, mostly because, of COVID, there is a reduction in the number of EDUs. And so we've gone down sewer EDUs by 81 EDUs and then there's a decrease of 35 EDUs for the water. So, that's something that will take into account as we're moving forward. But a. Big. Portion of it EDUs was a reduction from prison. They were down about half of their. Inmates last year. And they also didn't allow any visitors. So they had a big reduction in their usage last year. And about half of the EDUs are from the prison.
