(2023 NY Bridge Project funded with BFP Off-System) Locally Administered

RESOLUTION NUMBER: 2024-21

Authorizing the implementation and funding of the costs of a transportation project, which may be eligible for federal-aid and/or state-aid, or reimbursement from Bridge NY funds.

WHEREAS, a project for the Bridge at Gardner Street over Goose Bay, P.I.N. 775435 (the Project) is eligible for funding under Title 23 U.S. Code, as amended, 23CFR as amended and PUB. L. 117-58 also known as the "Bipartisan Infrastructure Law" (BIL); and

WHEREAS, the Village of Clayton will design, let, and construct the Project: and

WHEREAS, the Village of Clayton desires to advance the Project by making a commitment of 100% of the costs Preliminary Engineering/Design and Right-of-Way Incidentals or portions thereof.

NOW, THEREFORE, the Village Board, duly convened does hereby

RESOLVE, that the Village Board hereby approves the above-subject Project; and it is hereby further

NAY

RESOLVED, that the Village Board hereby authorizes the Village of Clayton to pay 100% of the cost of Preliminary Engineering/Design and Right-of-Way Incidentals work for the Project or portions thereof, with the understanding that qualified costs will be reimbursed from may be eligible for federal-aid, state-aid or reimbursement from BridgeNY funds; and it is further

RESOLVED, that the sum of \$254,895.00 is hereby appropriated from the Capital Fund and made available to cover the cost of participation in the above phase(s) of the Project; and it is further

RESOLVED, that the Village Board hereby agrees that the Village of Clayton shall be responsible for all costs of the Project which exceed the amount of federal-aid, state-aid, or NY Bridge funding awarded to the Village of Clayton; and it is further

RESOLVED, that in the event the Project costs not covered by federal-aid, state-aid, or NY Bridge funding exceed the amount appropriated above, the Village of Clayton shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the Mayor hereof; and it is further

RESOLVED, that Village of Clayton hereby agrees that construction of the Project shall begin no later than twenty-four (24) months after award and the construction phase of the Project shall be completed within thirty (30) months; and it is further

RESOLVED, that the Mayor of the Village of Clayton be and is hereby authorized to execute on behalf of the Village of Clayton all necessary agreements, certifications or reimbursement requests for federal-aid and/or state-aid with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the Village's initial funding of Project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project.
