### RESOLUTION STANDARDIZING NEW SEWER MAIN ON PVC PIPE

**WHEREAS**, the Village of Clayton, Jefferson County, New York, has existing sewer collection system main that is PVC, and

**WHEREAS**, Village employees are experienced and trained in the operation, maintenance and repairs associated with PVC pipe, and

**WHEREAS**, the Village maintains a spare parts inventory necessary to complete emergency repairs to PVC pipe which may be needed in the event of sewer main breaks and without use of Village staff could result in public and environmental health issues, economic impacts to local businesses, and added costs to the Village to retain outside contractors to complete repairs

**WHEREAS**, to allow new sewer mains to be installed that are of different composition (i.e., HDPE or Concrete) for replacement or sewer main extension projects would be inefficient and uneconomical for the Village to properly maintain and would not be consistent with the majority of new pipe that is installed in the Village's system

#### **NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:**

For reasons of efficiency and economy and pursuant to the authority conferred by General Municipal Law Section 130(56), it is determined by the Board of Trustees that there is a need for standardization in the material of construction for new sewer main piping.

The question of the adoption of the foregoing resolution was duly put to a vote, and upon roll call, the vote was as follows:


