## RESOLUTION #2025-06 RESCINDING JOINT TOWN/VILLAGE OF CLAYTON CODE ENFORCEMENT OFFICER (CEO) INTERMUNICIPAL AGREEMENT

At a regular meeting of the Board of Trustees of the Village of Clayton, held at the Village Municipal Building, Mary Street, Clayton, New York, on the 12<sup>th</sup> day of May, 2025, at 5:00 p.m., there were:

The following resolution was offered by Mayor Hyde, who moved it's adoption, seconded by Trustee Riddoch.

**WHEREAS**, the Village of Clayton entered into a Joint Town/Village of Clayton Code Enforcement Officer (CEO) Intermunicipal Agreement with the Town of Clayton on December 5<sup>th</sup>, 2016; and

**WHEREAS**, said IMA is no longer applicable to the use of the Joint CEO Intermunicipal Agreement; and

**WHEREAS**, The Village of Clayton Board of Trustees will hire separate from the Town their own Code Enforcement Officer.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Clayton that the Joint CEO Intermunicipal Agreement, dated December 5<sup>th</sup>, 2016, is hereby rescinded, and is therefore no longer in effect as of May 12<sup>th</sup>, 2025.
