RESOLUTION NO. 2026-01

Resolution by the Village of Clayton approving and endorsing North Jefferson Improvement Association in its application to NYS Homes and Community Renewal for funding under the MOVE-IN NY Program.

The foregoing Resolution no. 2026-01 was offered by Trustee Duford, and seconded by Trustee McDowell

WHEREAS, the North Jefferson Improvement Association desires to apply for financial assistance through the MOVE-IN NY Program; and

WHEREAS, the application proposes funding to support the purchase and installation of manufactured, "CrossMod" homes on a site located in the Village of Clayton; and

WHEREAS, the proposed funding will contribute to ongoing affordable housing development efforts; and

WHEREAS, the program application requires that the applicant obtain the approval and endorsement of the governing body of the municipality in which the proposed project will be located; and

WHEREAS, the program application requires that the governing body of the municipality in which the proposed project will be located affirm both its understanding of the CrossMod manufactured housing typology and its ability to approve siting and installation of HUD Code manufactured housing within the community without obstacles to permitting; and

NOW, THEREFORE, BE IT RESOLVED, that the Village of Clayton Board of Trustees approves and endorses the application for assistance prepared and to be submitted by North Jefferson Improvement Association and affirms its commitment to approving and expediting the siting and installation of manufactured "CrossMod" homes in the community.


